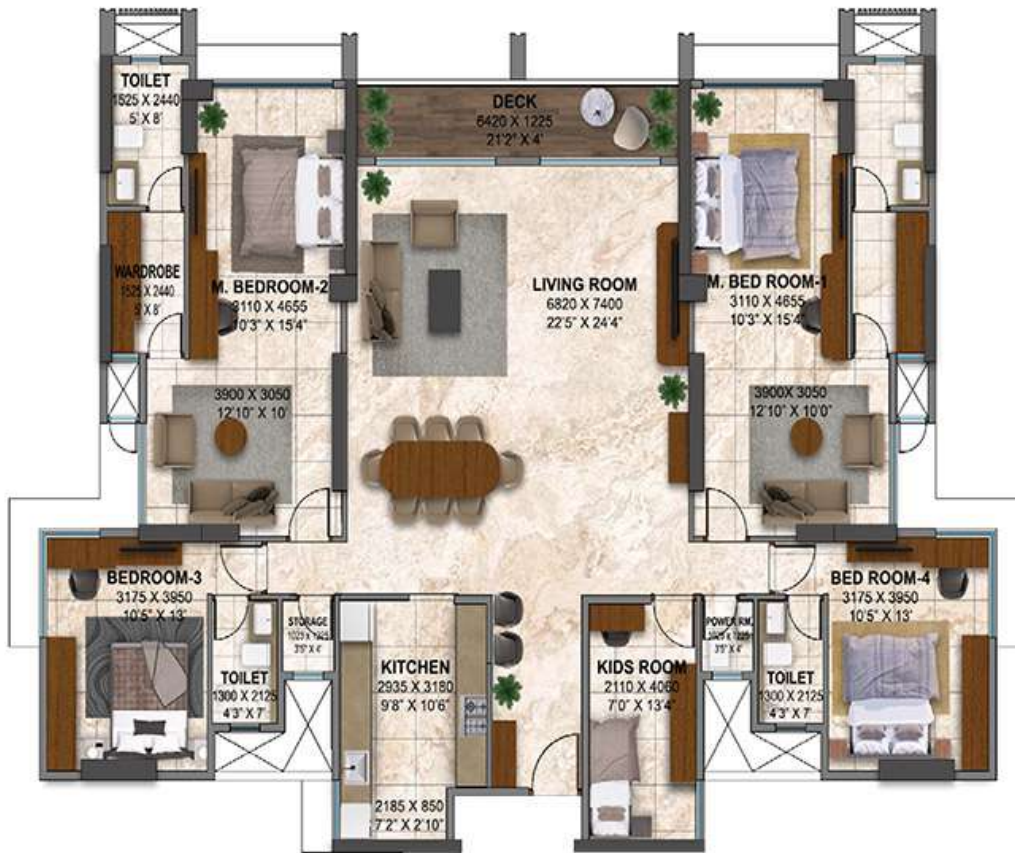
**TOWER F - JODI FLAT**
